



## EVENT LICENSE, RELEASE, HOLD HARMLESS WAIVER AND PLEDGE AGREEMENT

1. **Parties:** This Agreement is entered into for the benefit of **Rider's Edge Farm** a d/b/a/ of **VLH Training LLC**, its employees, owners, shareholders, officers and agents ("stable"), located at 11220 196<sup>th</sup> Ave Ne, Redmond Washington and with the undersigned attendee/releaser ("Releaser").
2. **License:** By signing this document, the Releaser accepts the grant to Releaser of a license to attend a training session, clinic, show, and exhibition, seminar, (Event) in the buildings and on the grounds of Stable which Releaser has inspected and accepts as suitable for Releaser's participation or attendance.
3. **Inducement by Releaser:** I, the undersigned Participant, desire to participate in using, riding, exhibiting or other involvement with horses and/or in other activities conducted at or from Stable. As part of the consideration for such participation, and to induce Stable to allow me to participate, I have agreed to this Release of Liability and Hold Harmless Agreement will apply to my participation in such activities on any date on or after the signature date indicated below, unless and until I give formal written notice to Stable that I will no longer be bound by this Release of Liability and Hold Harmless Agreement (in which case I understand that I may not be permitted to participate in any further activities).
4. **Acknowledgement and Assumption of Risk:** I understand that there are substantial risks and dangers inherent in keeping, training, transporting, approaching, and riding horses and related equestrian activities, both to myself and third parties. I realize that dangers may arise at any time, anticipated or unanticipated, including without limitation dangers to my life and the lives of third parties from the unpredictable nature of horse and from other causes such as acts or omissions or other riders, trainers and other persons. I voluntarily assume all risks and danger of injury, death, harm and/or damage to my person or my property and that of third parties, resulting from or arising out of conditions of or about the Stable premises and any trails or other areas accessible from such premises, or any of my activities on, at, or from such premises and trails and other areas, including all use, riding, transporting, or exhibition of any horse at Stable, or arising out of the treating, vetting, shoeing or trimming, or other services to any horse, or arising out of the escape of any horse at or from Stable, theft of any horse or property, or any other cause whether or not I Stable's control to the extent provided for in RCW 4.24.540. I accept full responsibility for all medical expenses incurred as a result of any of the foregoing.
5. **Release, Hold Harmless, Waiver, Pledge:** The undersigned release and agrees to indemnify and hold harmless the Stable, and on behalf of its wards, charges, children, family, visitors, agents, individually and as guardian or personal representative covenants not to sue for special and general damages, by whomever sustained, resulting from property damage, injury, or loss of life (claim) caused by the conditions on the Stable property, the activities of the Stable, its employees,

guests, clients, and boarders and their family or guests and the Releasor's Horse, and further agrees to hold harmless and indemnify the Stable against any such Claim whether presented by another, individually, or in a representative capacity and further waives and releases subrogation claims of all medical, disability, property and liability insurers, including, but not limited to damage resulting from medical and convalescent care, cost of support; and , as security interest in all money and proceeds arising from any such Claim including insurance proceeds, trust and guardianship remainders and proceeds from testate or intestate succession, which Releasor agrees not to relinquish or disclaim.

6. **Parent/Guardian:** If the Participant named above is a minor, I, the undersigned Parent or Guardian, am signing this Release of Liability and Hold Harmless Agreement individually and on behalf of the Participant and (unless I am single) my martial community. I verify that I am the Parent or guardian of the minor Participant and I have authority to enter into this Release of Liability and Hold Harmless Agreement on behalf of the Participant and my marital community, if any.
7. **Hard-hat Waiver:** I, the undersigned recognize the dangers inherent with horseback riding. I am assuming the risk of this hazard upon myself since I wish to handle and ride horses. I realize I am subject to injury from this activity and no form of preplanning can remove all danger o which I am exposing myself. The use of a hard-hat could prevent permanent brain damage in the case of an accident. I assume all risks involved in handling and riding horses without a hard-hat.
8. **Attorney Fees:** Should attorney's fees be incurred by either party enforcing their rights or obligations under this Agreement, the court shall award the prevailing party reasonable attorney's fees.
9. **Effective Period:** The License granted herein and the release, hold harmless. Indemnity, waiver, and pledge, shall remain in effect and in force until terminated by either party in writing, so as to be applicable at subsequent Events.
